We are here to help lowans make a positive, local impact by offering a variety of tools to help people achieve their charitable goals and do good work in their communities that lasts forever.




- > Educates people on charitable giving vehicles






- The Iowa Council of Foundations (ICoF)
 sponsored initial legislation (Endow Iowa) in 2003
 - Recognized importance of philanthropy
 - Provided incentives
- Endow lowa Tax Credits
 - Possible 20% additional credit on an endowment gift to a qualified Community Foundation
 - The allocation is limited per year on a first come-first serve basis

- Audubon County Endowment Fund
 Meeting ever-changing community needs
- Field of Interest Endowed Fund Addressing needs in an important area of community life: arts, AIDS, aging, at-risk youth...
- Designated Endowed Fund
 Directing gifts to specific agencies or purposes (e.g., scholarship)
- Donor Advised Endowed Fund Involving donors in the use of their gift
- Agency Endowed Fund Providing income for nonprofit organization.

Charitable instruments



Outright Gifts

Give cash, stocks, potentially real estate or other assets

> Bequests

Designate a portion of an estate

Charitable Gift Annuity

Annuity contract pays client for life and charitable fund commences grants upon death

Charitable Lead Trust

Trust pays the community foundation a fixed amount for a number of years and then assets go to beneficiary

> Charitable Remainder Trust

Trust pays beneficiary for life and then assets transfer to community foundation

> Life Estate Contract

Donor transfers home to community foundation and still enjoys use while living





Background:

- Left a bequest of \$6.2 million in 1958 to his local community foundation



The power of endowment funding




His gift is now funding:

The power of endowment funding



Consider planting a seed that will grow giving forever.

By establishing a fund today at the Audubon County Endowment Fund with a gift of \$25,000 in 25 years you will have provided \$46,172 in grants and the endowment will be valued at \$69,257.*


